We, Novatex Limited herewith confirm that the overall migration results of our **PolyEthylene Terephthalate (PET Resin) Polyester Chips bottle grade Gatronova A-80** was found to be below the overall migration limits defined in **EC Directive 2002/72/EC, UK Statutory Instrument 1376 (1998)** as well as in French law / Doc. No. 1227 < *materiaux au contact des aliments edeures destines alimentation humaine* « issued by the Journal office de la Republic Francaise » .

Our monomers and additives which are listed with specific migration limits in **section A of EC Directive 2002/72/EC** as amended (**terephthalic acid, isophthalic acid, ethylene glycol and an antimony based additive**) are not exceeding the limits specified for these substances in EC Directive 2002/72/EC.

Furthermore, Novatex confirms that **PolyEthylene Terephthalate (PET Resin) Polyester Chips bottle grade Gatronova A-80** does not contain any **Bovine Spongiform Encephalopathy (BSE)** agent as well as none of the **Specified Risk Materials (SRMs)** or combination of these are used in the manufacturing process of this PET resin.

PolyEthylene Terephthalate (PET Resin) Polyester Chips bottle grade Gatronova A-80 is particularly suitable for use in bottles which may be used to pack still and sparkling mineral waters, carbonated and non-carbonated soft drinks, alcoholic beverages, edible oils in all temperature conditions of use, including those encountered in oven cooking and baking at temperatures above 250 °F under the full compliance of Federal Food, Drug and Cosmetic Act and all food applicable regulations including 21 CFR §177.1630 (Polyethylene Phthalate Polymers).

This declaration is limited to the above product only and does not refer to the suitability of the other additional substances that may be used with the product to manufacture finished materials and articles.
